Secure Trip Handle and Bracket with Hardware shown below.





Note:

It is not recommended applying any grease or heavy lubricant to moving parts on the Landscape Rake. Grease and heavy lubricants will attract dirt and abrasive materials causing moving parts to wear.

We recommend that cleaning with pressure washer or garden hose to remove excess dirt and grim after each use.

To prevent rust afterwards apply a light coat of WD-40 and let dry.



Note:

After each use check all hardware for any loose or damaged components. Tighten if needed, replace all warn or damaged hardware or components prior to next use.

Warranty and Limitations:

Impact Implements offers a limited one (1) year warranty for each new product against manufacturing defects in workmanship and materials. Exterior parts and finish (Paint, Powder Coating or Plating) are warranted against defects in original workmanship and materials. No warranty applies to exterior finish (Paint, Powder Coating or Plating) after initial use.

The entire warranty is void if the product is used in commercial/industrial applications.

Wear Bars and Skid Feet or Pads, Rake Tines, Disc Plow disc's, Plow or S-Tines and Tires are considered wearable parts and are warranted against defects in original workmanship and materials.

No warranty applies to wearable parts after initial use.

The obligation under this warranty, statutory or otherwise, is limited to the replacement or repair of such part as shall appear to the manufacturer, upon inspection of such part, to have been defective in material or workmanship. This warranty does not obligate Impact Implements to bear the cost of shipping charges in connection with the replacement or repair of defective parts, nor shall it apply to a product upon which repairs or alterations have been made, unless authorized by Impact Implements, or for equipment misused, neglected, or improperly installed.

WARRANTY CLAIMS:

If warranty parts are required, Impact Implements may send replacement parts free of charge to owners in the US and Canada. Other international locations will be required to pay for shipping charges on those parts. If in-person diagnosis is required, the owner is responsible for shipping charges connected to getting the product to Impact Implements. Typical service time would be three (3) weeks from receipt of returned item by Impact Implements to receipt of item to owner.
